1. Assignment of Rights  
The rights owner grants the SUB Göttingen the permanent, irrevocable, non-exclusive right to make publicly accessible the document and to archive it on [e-docs.geo-leo.de](http://e-docs.geo-leo.de), the document server of the SUB Göttingen (FID GEO). All copyright protections will continue to remain in force on account of this license. The act of uploading a document does not constitute a legally binding right to publication or archiving.
2. Third-party Rights
